### ASSIGNMENT

WHEREAS I, **BOLLARD, Jerome**, a citizen of France, residing at Schlesierstrasse 22A, 60388 Frankfurt am main, Germany (hereinafter referred to as the "ASSIGNORS"), has invented certain new and useful improvements in **FAST SETTING SHEET FED OFFSET INKS WITH NON-AQUEOUS DISPERSION POLYMERS** which was described and claimed in International Application No. **PCT/US2009/047059** filed on **June 11, 2009** and for which we have executed an application for Letters Patent of the United States as Application Serial No. **12/999,388** and whereas **SUN CHEMICAL CORPORATION**, a corporation having an office and principal place of business at 35 Waterview Boulevard, Parsippany, New Jersey 07054-1285 (hereinafter referred to as the "ASSIGNEE"), is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application;



AND ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to record this Assignment, and to issue all Letters Patent for the improvements to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND ASSIGNOR HEREBY covenant that ASSIGNOR has the full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed, and will not execute, any agreement, assignment, sale or encumbrance in conflict herewith.

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting the improvements, and will testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.
