At the expense of said ASSIGNEE, ASSIGNOR agree to testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, continuation-in-part, reissue, and substitute applications; make all lawful oaths; and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.


