**ASSIGNMENT OF INVENTION
AND OF LETTERS PATENT**

Whereas, I, Bruce M. Rippe, of 18 Red Oak Drive, Batesville, Indiana 47006, have invented certain improvements in a mattress and bed deck cover, (hereinafter "Invention") and am filing a U.S. patent application therefor ("Application"); and
