ASSIGNMENT

WHEREAS, Edward E. LAFLEUR of 33 Hope Road, Holland, PA 18966 and Jiun-Chen WU of 3 Oakwood Way, Robbinsville, NJ 08691 (hereafter Assignors), invented certain new and useful improvements in **LIGHT-SCATTERING COMPOSITIONS THE SAME** (hereafter "INVENTION") for which on the date below Assignor executed an application for Letters Patent of the United States of America;
