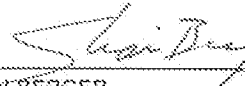
WHEREAS, FONCLOUD, INC., a Canadian corporation, hereinafter referred to as Assignee, is desirous of acquiring the same;

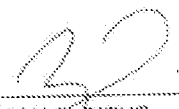
