Invention and Patent and the Assignee accepts the assignment.

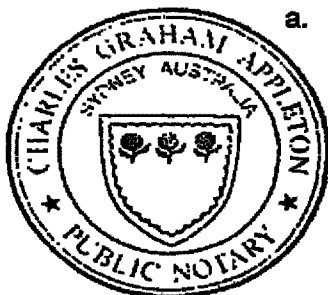
Consideration:

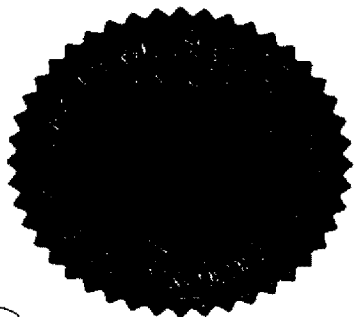
