

AND **RAMSD** HEREBY covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

AND **RAMSD** HEREBY further covenants and agrees that it will communicate to the said **Landscape Forms, Inc.**, its successors, legal representatives and assigns, any facts known to **RAMSD** respecting said improvements, and will provide testimony in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Landscape Forms, Inc.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.


