We confirm that at the time the invention was made, we were under an obligation to assign the invention to Taylor Made Golf Company, Inc.

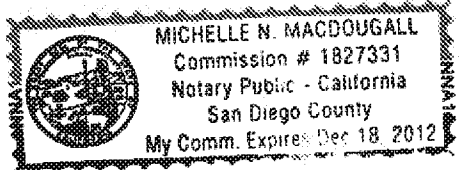


