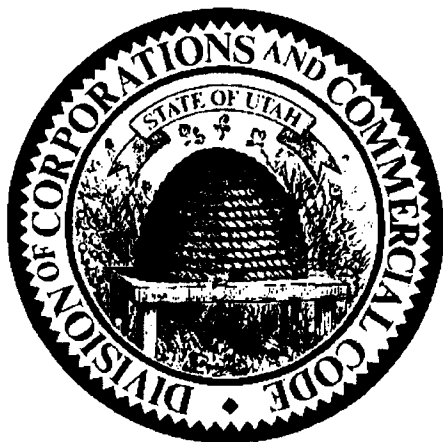

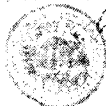

Name. The Company's name is Gazinga, LLC

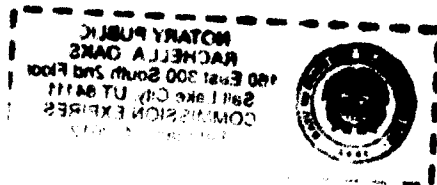
3. The foregoing amendment to Article 1 of the Articles of Organization was adopted by the members and the managers of the Company on October 19, 2010.
