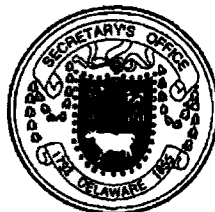

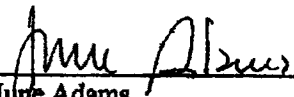

I THE UNDERSIGNED, being authorized to execute a certificate of amendment of certificate of formation of Voest-Alpine Services & Technologies LLC, a limited liability company organized and existing under and by virtue of the Delaware Limited Liability Company Act, DO HEREBY CERTIFY:

1. The name of the limited liability company is Voest-Alpine Services & Technologies LLC.
2. That Article 1 of the Certificate of Formation be, and hereby is, amended to read in its entirety as follows:
 1. The name of the limited liability company is Siemens VAI Services, LLC.

Upon the receipt from Siemens Aktiengesellschaft, a corporation organized and existing under the laws of the Federal Republic of Germany and which has granted this Company the right to use the name "Siemens", or from its legal successor or duly authorized agent, or from any of its subsidiaries authorized on its behalf to control the use of the name Siemens, of a written request that this Company cease to use the name Siemens as a corporate name, any authorized officer of the Company is authorized and directed to execute and file a Certificate of Amendment to the Certificate of Formation of the Company, changing the name of the Company to any name acceptable to the Secretary of State of Delaware which shall not contain the name Siemens in any form, nor any variation thereof, nor any word that indicates that the Company is related to Siemens Aktiengesellschaft or any affiliate thereof. Such amendment shall also delete this paragraph of Article 1.
