ASSIGNMENT

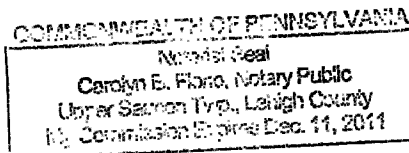

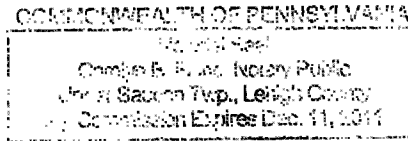

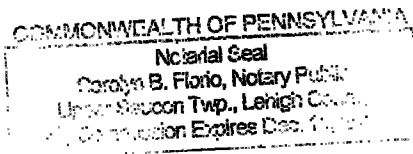
