assigning the invention to Taylor Made Golf Company, Inc.

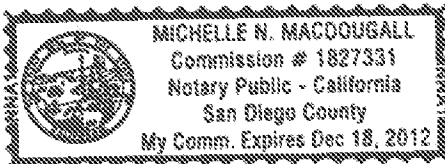
