## RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (the "Release"), is granted and conveyed as of this 15 day of December, 2010, by Bank of Scotland plc, as agent and security trustee ("Agent"), in favor of MAAG Pump Systems, Inc., formerly MAAG Pump Systems Textron Inc. ("Obligor").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby releases, discharges, and relinquishes its security interest in the Released Patents. Agent specifically acknowledges that its security interest in the Released Patents is no longer in force.
