## ASSIGNMENT

WHEREAS I, Reinhard Evers, a German citizen, residing at Jahnstr. 5, 23617 Stockelsdorf, Germany, have invented certain new and useful improvements in a "Holding device for securing eviscerated poultry carcasses or parts thereof", for which I have filed a patent application in the United States Patent Office, Ser. And, we do hereby request and authorize the Commissioner of Patents to issue said Letters Patent, when granted, in accordance with this assignment.


