The undersigned certify that:

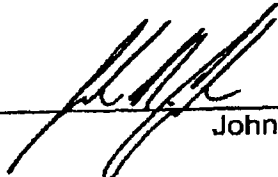
1. They are the President and an Assistant Secretary, respectively, of Advanced Cardiovascular Systems, Inc., a California corporation.
