ASSIGNMENT

ASSIGNOR hereby furthermore sells, assigns, and transfers to ASSIGNEES all claims for past, present, and future infringement of the inventions covered by Patent Rights, including without limitation all rights to recover damages and the right to grant releases for past infringement of the Patent Rights.

ASSIGNOR hereby further covenants and agrees, to render such assistance to ASSIGNEE as may be necessary to perfect the title to Patent Rights in said ASSIGNEE, its successors and assigns, to enable ASSIGNEE to prosecute all divisional, continuation, reexamination, and reissue applications, and to enable ASSIGNEE to obtain and enforce patent protection for the Patent Rights.

ASSIGNOR HEREBY covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

ASSIGNOR further covenants that (i) ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to the Patent Rights as may be known and/or accessible to ASSIGNOR, (ii) ASSIGNOR shall testify as to the same in any interference or litigation related thereto, and (iii) ASSIGNOR shall promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain or enforce the

Patent Rights and/or any intellectual property rights evolving therefrom. ASSIGNOR shall use his best efforts to cooperate in good faith with ASSIGNEE.

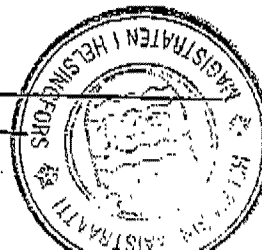
