ASSIGNMENT

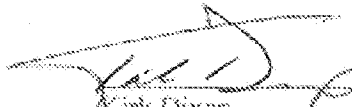

such facts relating to said invention and Letters Patent or the history thereof, as may be known to them, and testify as to the same in any interference or other litigation, when requested to do so.

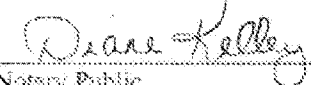

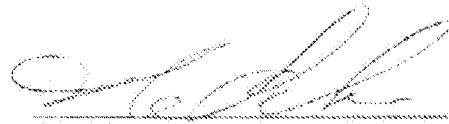

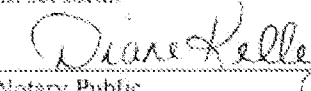
