


- (i) Assignor and its Affiliates retaining a world-wide, royalty-free, non-exclusive, unrestricted and irrevocable license under the Patent right for the lifetime of the Patent right, to use the Patent right for and in any and all activities and applications that it or its Affiliates see fit, including, without limitation, the right to manufacture, use, import, offer to sell, sell or otherwise dispose of any product (including software), process or service including the right to have any such product made for it and/or its Affiliates or sold or otherwise disposed of for it or its Affiliates by third parties; and
- (ii) all prior commitments and prior undertakings vis-à-vis third parties entered into by Assignor or its Affiliates;

and Assignee has accepted said assignment.

The assignment of right and title in and to the Patent right to Assignee does not include the right to claim for damages resulting from any act of infringement having occurred prior to the effective assignment date specified above. That right is retained by Assignor.

Assignor hereby grants full power of attorney to Assignee to submit this Deed of Assignment deed to the patent authorities of USA and to request those authorities to record the assignment of the legal title to the Patent right from Assignor to Assignee in the appropriate registers provided that, where possible, the retained license to Assignor and its Affiliates shall be simultaneously recorded in those registers.
