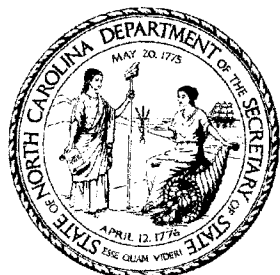

2. The text of each amendment adopted is as follows (attach additional pages if necessary):

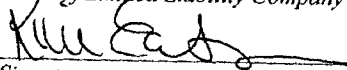
RESOLVED, that the Articles of Organization of GE MORTGAGE HOLDINGS, LLC be amended, effective
