ASSIGNMENT

WHEREAS, I, George J. Mistic, a citizen and resident of the United States of America, whose post office address is 1936 Duncan Avenue, Allison Park, Pennsylvania 15101 (hereinafter collectively referred to as ASSIGNOR), have invented within the United States and own a certain invention entitled
