I agree that, when requested, I will, without charge to said Assignee, but at Assignee's expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable, or convenient for securing and maintaining patents for the Invention in any and all countries and for vesting of title thereto in the Assignee, his successors, assigns and legal representatives, or nominees.

I authorize and empower said Assignee, his successors, assigns and legal representatives, or nominees, to invoke and claim for any application for patent or other form of protection for the Invention


filed by him or them, the benefit of the right of priority provided by the Paris Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it or may supplement it, and to invoke and claim such right of priority without further written or oral authorization from me.

I hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the Assignee, his successors, assigns and legal representatives, or nominees, to claim the aforesaid benefit of the right of priority provided by the Paris Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, or may supplement it.


