ARTICLE I.

The name of the Corporation is R.A. Hanson Company, Inc. (the "Corporation").

The amendment to the Articles of Incorporation of said corporation is as follows:
ARTICLE I shall be amended to read as follows

"The name of this Corporation shall be RAHCO International, Inc., and its existence shall be perpetual."

The amendment provides for no exchange, classification, or cancellation of issued shares.

ARTICLE IV.

The amendment was adopted on October 21, 1997.

The date of the amendments' adoption was March 29, 2007.

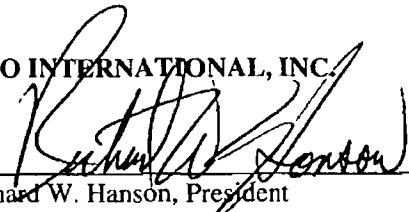
