AZAB hereby authorizes and requests any official of any country, whose duty it is to issue patents on applications, to issue each and every letters patent to be granted that is a Patent, and each and every reissue, conversion, or prolongation of said letters patent, to MedI Ltd, its successors, legal representatives and assigns, as the assignee of the AZ AB's entire right, title and interest therein.

AZAB hereby agrees to execute, and direct its representatives, successors and assigns to execute, any and all further papers which MedI Ltd may consider necessary or desirable to vest or perfect the title of MedI Ltd and its successors, assigns or legal representatives in and to said Patents, or for maintaining, enforcing or defending same.

THIS DEED OF ASSIGNMENT shall be governed by and construed in accordance with the laws of England.
