Patent Purchase Agreement

dated as of December [14], 2010

(hereinafter Buyer)

(Seller and Purchaser each a **Party** and together the Parties)

This Patent Purchase Agreement (the **Agreement**) is made as of December [], 2010 by and between Viditech AG (Seller) and DockOn AG (Buyer).

Whereas

- A. Seller is the registered owner of the patent application as per Annex 1 (the **Patents**).
- B. Buyer is interested to purchase the Patents from Seller.

Now, therefore, the Parties hereto agree as follows:

1. Subject Matter of Purchase

The Seller agrees to assign and hereby assigns to the Buyer the Patents, with all rights and obligations connected thereto. The Patents remain the property of Seller until the Price as defined in Clause 2 has been paid in full. Seller grants the Buyer a worldwide exclusive license to use the Patents from the date of execution of this Agreement until the Price is paid pursuant to Clause 2, but in no case longer than for 90 days unless such price has been paid in full as per Clause 2 below.

2. Price

The price for the Patents is [REDACTED] (the **Price**). This Price shall be paid within 90 days of the execution of this Agreement.

3. Recordal

After full payment of the Price has been effected, the Seller shall agree to the recording of the assignment of the Patents in the relevant registers, and Seller shall provide the required documents and undertake all necessary acts in order to effect this registration.

4. No-challenge clause

The Seller promises not to attack the Patents and not to assist third parties in attacks on the Patents.

5. Costs

The costs and fees of this Agreement as well as the costs for the assignment and the recording of the Patents will be borne by the Buyer. The Buyer will also pay all fees and costs for maintenance of the Patents after the execution of this agreement.

6. General Provisions

6.1 Entire Agreement

This Agreement, including the Annexes and any other documents referred to herein, constitutes the entire agreement and understanding among the Parties with respect to the subject matter hereof, and shall supersede all prior oral and written agreements or understandings of the Parties relating hereto. All references to this Agreement shall be deemed to include the Annexes hereto.

6.2 Amendments and Waivers

This Agreement may only be modified or amended by a document signed by all Parties. Any provision contained in this Agreement may only be waived by a document signed by the Party waiving such provision.

6.3 Severability

Should any part or provision of this Agreement be held to be invalid or unenforceable by any competent arbitral tribunal, court, governmental or administrative authority having jurisdiction, the other provisions of this Agreement shall nonetheless remain valid. In this case, the Parties shall negotiate in good faith a substitute provision that best reflects the economic intentions of the Parties without being unenforceable, and shall execute all agreements and documents required in this connection.

7. Governing Law and Jurisdiction

7.1 Governing Law

This Agreement shall be governed by and construed in accordance with the substantive laws of Switzerland, with the exclusion of the Vienna Convention on the International Sale of Goods dated April 11, 1980.



7.2 Jurisdiction


All disputes arising out of or in connection with this agreement, including disputes on its conclusion, binding effect, amendment and termination, shall be resolved exclusively by the Commercial Court of Zurich (*Handelsgericht des Kantons Zürich*).




