Deed of Assignment

This Deed of Assignment is made as of December 2, 2010 and is effective as of this date

By and Between:

- (1) **Overseas Diamonds Technologies NV**, a company organized and registered under the laws of Belgium, under registration number 0477.137.555, with a registered office at Hoveniersstraat 2-8, 2018 Antwerp, Belgium ("**Assignor**") and
- (2) **Sarin Color Technologies Ltd.**, a company organized and registered under the laws of the State of Israel, under Company number 51-133220-7, with a registered office at 7 Atir Yeda Street, Kfar Saba, Israel ("**Assignee**").


and

Whereas: Assignor is the sole owner of the Patents and Patent applications herewith attached and labeled ANNEX A, for "Apparatus for generating data and determining a property of a gemstone and method determining a property of a gemstone" (the "**Patents and Patent Applications**"), describing a certain invention for generating data and determining a property of a gemstone (the "**Invention**"); and

Whereas: Assignee had expressed its interest and its desire to acquire all the rights, all around the world, in and to the Patents, Patent Applications and the Invention and Assignor had agreed to assign to Sarin Color Technologies all rights in and to the Patents, Patent Applications and the Invention, all in accordance with the terms and conditions of this Assignment.

NOW THEREFORE, in consideration of the mutual covenants set forth herein, and other good and valuable considerations, the receipt and adequacy of which are hereby acknowledged, Assignors and Assignee, intending to be legally bound, agree as follows:

1. Assignor hereby assigns, with full title guarantee, all rights in and to the Invention all around the world, including (but not limited to) all rights in and to the Patents and any other provisional patent applications, patent applications and/or patents that relate to the Invention (collectively "**the Assigned Rights**"), together with the right to apply for and obtain patents or other similar forms of protection in respect of the Assigned Rights throughout the world together with the right to make any new application or applications in respect of any part or parts of the subject matter of any application or specification filed in connection with the Assigned Rights anywhere in the world, including without limitation the right to apply for reinstatement of restoration or the like of any patent or patent application, and the right to claim priority from the Assigned Rights under any applicable law, the Paris Convention (as amended) or other conventions together with the right to bring proceedings for any past, current or future infringement and to hold the same unto the Assignee and its respective successors and assigns absolutely.
2. As of the signing of this Agreement by both parties, Assignor shall have no further rights to the Invention the Patents, Patent Applications and hereby waives any claim or demand whatsoever in connection therewith, all around the world.



Without derogating from the above, Assignor hereby irrevocably appoints Assignee, its successors and assigns, as its true and lawful attorney empowering Assignee to take all actions, execute all acts, deeds, matters and things, including but not limited to signing all documents necessary for completing the assignment of the Assigned Rights, including the Patents and Patent Applications and recording same with any Patent office around the world.


