Deed of assignment and delivery of design patent registration

Parties:

UNmi Investments B.V. , located at Polarisavenue 97, 2132 JH Hoofddorp, The Netherlands, hereinafter: "Assignor"

and

Aristides Instruments Holding B.V. , located at Polarisavenue 97, 2132 JH Hoofddorp, The Netherlands, hereinafter: "Assignee"

Whereas:

- Assignor holds the design patent registration, registered on 11 August 2009 under number US D598,044 S at the United States Patent and Trademark Office. Hereinafter: Design Patent.
- Assignor wishes to assign the Design Patent to Assignee and Assignee wishes to become holder of the Design Patent.
- Parties wish to lay down their agreement on the assignment and delivery of the Design Patent, as well as their mutual rights and obligations in this deed.

Have agreed as follows:

Article 1: Assignment

1. Assignor hereby assigns unconditionally and without any restriction to Assignee and delivers unconditionally and without any restriction to Assignee all rights to the Design Patent, including the priority rights, goodwill, rights arising from the use of the Design Patent and the right to claim damages from third parties and otherwise to take legal action against third parties who infringe upon the rights in the Design Patent, regardless of whether the infringement took place before or after the date of this agreement.
2. Assignee hereby accepts the assignment and delivery of the rights to the Design Patent in consideration of the sum of € 1,00 (one Euro) now paid by the Assignee to Assignor (the receipt whereof Assignor hereby acknowledges).

Article 2: Warranties and liabilities

1. Assignor warrants that it is fully entitled to the Design Patent and that it is authorised to assign the Design Patent. Assignor guarantees that the Design Patent is valid, that the rights to be assigned are not subject to any lien, seizure or license. Assignor agrees to indemnify and hold Assignee harmless from any such claim.


2. At the request and at the expense of the Assignee, Assignor will do all reasonable acts, execute all documents and procure the making of any declarations or oaths necessary or required by law for further effecting the assignment of the Design Patent to Assignee and assisting Assignee in recording the assignment of the Design Patent.

Article 3: Choice of law and jurisdiction

1. This agreement is governed by Dutch law.
2. Any dispute arising in connection with this agreement, including any dispute concerning the existence and validity of this agreement, shall be submitted exclusively to the courts of the Netherlands.
