Assignment of Patent Rights

Jozsef Constantin SZELES hereby warrants that he has full rights in said patent applications/patents and has the right to assign said patent applications/patents. Medizinische Universität Wien has the right to claim ownership in the invention according to Art. 106 Universitätsgesetz 2002 (UG2002), and according to Austrian Patent Law.

Jozsef Constantin SZELES further transfers and assigns to Medizinische Universität Wien all causes of action, rights, and remedies arising under any such patents or patent applications prior to or after the effective date of this Agreement. Effective date shall be October 20, 2010.
