Bernstein, or his/her designee, to execute on Assignors' behalf any documents necessary to evidence the assignments granted herein for the United States or any other country without further notice to Assignors.


And we do hereby authorize and request the Commissioner for Patents of the United States to issue such Letters Patent as shall be granted upon said application or applications based thereon to Assignee, its successors and assigns.
