ASSIGNMENT

WHEREAS, I, the undersigned,

Dominique JOUBERT, resident of **10 rue Gabriel Péri, Sète, 34200, France;**

have invented certain new and useful improvements in "**MONOCLONAL ANTIBODIES TO PROGASTRIN AND THEIR USES**" and have executed an application for a patent of the United States, having Serial No. **12/906,041**, filing date of **15 October 2010**, and

Such cooperation by me shall include prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by said Assignee (a) for perfecting in said Assignee the right, title and interest herein conveyed; (b) for prosecuting any of said applications; (c) for filing and prosecuting substitute, divisional, continuing or additional applications covering said invention; (d) for filing and prosecuting applications for reissuance of any said patents; (e) for interference or other priority proceedings involving said invention; and (f) for legal proceedings involving said invention and any applications therefor and any patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by me in providing such cooperation shall be paid for by said Assignee.

3. The terms and covenants of this assignment shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon me, my respective heirs, legal representatives and assigns.

4. I hereby warrant and represent that I have not entered and will not enter into any assignment, contract, or understanding in conflict herewith.
