PATENT AND TRADEMARK ASSIGNMENT

This Patent and Trademark Assignment (this "Assignment") dated August 31, 2007, by Elementis Pigments Inc., a Delaware corporation (the "Elementis US Company"), Elementis UK Ltd., a corporation organized under the laws of England and Wales ("Elementis UK Company"), Elementis Specialties, Inc., a Delaware corporation ("Elementis Specialties"), and Elementis Specialties Netherlands BV, a Netherlands private limited liability company ("Elementis Netherlands", and together with Elementis US Company, Elementis UK Company and Elementis Specialties, the "Assignors"), in favor of Rockwood Pigments NA, Inc., a Delaware corporation (the "Assignee").

WHEREAS, Elementis Holdings Ltd., a limited company incorporated under the laws of England and Wales ("Elementis Holdings"), and Rockwood Specialties Group, Inc., a Delaware corporation ("Rockwood Specialties"), have entered into an Asset Purchase Agreement dated as of May 10, 2007, pursuant to which Elementis Holdings has agreed, among other things, to sell, convey, transfer and assign, or cause to be sold, conveyed, transferred and assigned, to Purchaser (or one or more of its permitted assignees) all right, title, and interest of the Assignors in and to (i) the patents and patent applications listed on Exhibit A hereto (the "Patents") and (ii) the trademarks and trademark applications listed on Exhibit B hereto (the "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignors hereby assign, transfer, convey and deliver to the Assignee, its successors and assigns, effective as of the date first referred above, all right, title, and interest of the Assignors in and to:

the Patents and the Trademarks;

all registrations and pending applications to register or otherwise obtain legal protection, domestic and foreign, for any of the foregoing;

all rights to make application, domestic and foreign, in the future to register or otherwise obtain legal protection for any of the foregoing;

all rights of priority under national laws, domestic and foreign, and international conventions with respect to any of the foregoing;

all domestic and foreign continuations, continuations-in-part, divisions, renewals, extensions, patents of addition, reexaminations, or reissues of any of the foregoing and all related applications therefor;

all income, royalties, damages, and payments now or hereafter due or payable in respect thereto;

all goodwill of the business associated with the Trademarks;

all causes of action (either in law or equity), and the right to sue, counterclaim, and recover for past, present, and future infringement, misappropriation, or dilution thereof of any of the foregoing; and

all other rights and privileges corresponding thereto throughout the world;

the same to be held and enjoyed by the Assignee for its own use and enjoyment and for the use and enjoyment of its successors, assigns and other legal representatives, to the end of the term or terms for which the foregoing are registered, issued, granted, reissued, or extended, as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment and sale had not been made.

The Assignors further agree, without further consideration, to execute and deliver, or arrange for the execution and delivery of, such further documents and instruments as the Assignee may reasonably request, to effectuate and record this Assignment and the assignment of the Patents, Trademarks and any other intellectual property rights purported to be transferred hereunder, including execution of assignments in recordable form in each jurisdiction where registrations or applications for the Patents and Trademarks may be issued or pending and to take the steps necessary to put in the name of Assignors all of the Patents and Trademarks being transferred hereunder.
