## DEED OF ASSIGNMENT

THIS DEED is made this *13th* day of *March* 1996  
but effective as of 1 July 1993

**NOW THIS DEED WITNESSETH** pursuant to the foregoing and in consideration of the sum of one dollar (\$1.00) and for other valuable consideration in hand well and truly paid to the assignor by or on behalf of the assignee the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed between the parties as follows:

1. The assignor hereby assigns to the assignee his entire right, title and interest in and to the said invention, the said Patent Application, including the right to claim Convention priority therefrom and any

patent granted pursuant to the said invention in Australia and all other countries of the world.

- 2. The assignor hereby undertakes at the expense of the assignee to do all acts and execute all documents necessary or desirable for further assuring the title of the assignee to the invention and for obtaining and securing patent and corresponding protection in Australia and all other countries of the world.
