

**PATENT SECURITY AGREEMENT**

(PATENTS, PATENT APPLICATIONS AND PATENT LICENSES)

WHEREAS, Kirby Lester, LLC, a Delaware limited liability company (herein referred to as "Grantor"), owns the Patents listed on Schedule 1 annexed hereto, and is a party to the Patent Licenses listed on Schedule 1 annexed hereto;

WHEREAS, reference is made to that certain Credit and Guaranty Agreement dated as of July 11, 2007 (as amended, restated, supplemented or modified from time to time, the "Credit Agreement") among the Grantor, Kirby Lester Holdings, LLC, certain subsidiary guarantors from time to time party thereto, the financial institutions from time to time party thereto (together with their respective successors and assigns, "Lenders") and Silver Point Finance, LLC, as administrative agent and collateral agent for the Lenders; and

WHEREAS, pursuant to the terms of the Pledge and Security Agreement dated as of July 11, 2007 (as amended, restated, supplemented or modified from time to time, the "Security Agreement" among Grantor, the other grantors party thereto and Silver Point Finance, LLC, as collateral agent for the secured parties referred to therein (in such capacity, together with its successors in such capacity pursuant to the terms of such Security Agreement, "Grantee"), Grantor has granted to Grantee for the ratable benefit of such secured parties a continuing security interest in or other Lien (as defined in the Credit Agreement) on substantially all the assets of the Grantor, including all right, title and interest of Grantor in, to and under the Patent Collateral (as defined below), whether now owned or existing or hereafter acquired or arising, to secure the Secured Obligations (as defined in the Security Agreement);

WHEREAS, Grantor entered into a patent security agreement executed July 11, 2007 (the "Prior Patent Security Agreement") with Grantee as collateral agent for secured parties;

WHEREAS, as part of the Prior Patent Security Agreement, Grantor granted to Grantee security interests in a number of patents or patent applications (herein referred to as "Prior Patent Collateral"), and the Prior Patent Collateral mistakenly included a number of third party patents or patent applications (herein referred to as "Third Party Patents"), which are listed in Schedule 2;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Any and all security interests in the Third Party Patents are null and void as of the July 11, 2007 date of execution of the Prior Patent Security Agreement.

Grantee hereby releases any and all security interests in the Third Party Patents.

Grantor does hereby grant to Grantee, to secure the Secured Obligations, a continuing security interest in all of Grantor's right, title and interest in, to and, under the following (all of the following items or types of property being herein collectively eased to as the "Patent Collateral"), whether presently existing or hereafter arising or acquired:

(i) each Patent (as defined in the Security Agreement) owned by Grantor, including, without limitation, each Patent and Patent application referred to in Schedule 1 hereto;

(ii) each Patent License (as defined in the Security Agreement) to which Grantor is a party, including, without limitation, each Patent License identified in Schedule 1 hereto; and

(iii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by Grantor against third parties for past, present or future infringement of any Patent, including, without limitation, any Patent referred to in Schedule 1 hereto, and all rights and benefits of Grantor under any



Patent License, including, without limitation, any Patent License identified in Schedule 1 hereto.

Grantor hereby irrevocably constitutes and appoints Grantee and any officer or agent representing Grantee, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority in the name of Grantor, from time to time, in Grantee's discretion, so long as any Event of Default (as defined in the Credit Agreement) shall have occurred and be continuing, to take with respect to the Patent Collateral any and all appropriate action which Grantor might take with respect to the Patent Collateral and to execute any and all documents and instruments which may be necessary or desirable to carry out the terms of this Patent Security Agreement and to accomplish the purposes hereof.

Except to the extent permitted in the Security Agreement or the Credit Agreement, Grantor agrees not to sell, license, exchange, assign or otherwise transfer or dispose of, grant any rights with respect to, or mortgage or otherwise encumber, any of the foregoing Patent Collateral.




