## CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment is made the 14<sup>th</sup> day of December 2010

### **Between:**

- (1) Eumedic Limited in Administration, a British Company, whose registered office is at c/o Bond Partners LLP Suite 2, 1<sup>st</sup> Floor, Turnpike Gate House, Birmingham Road, Alcester B49 5JG (formerly trading from 3 Charnham Lane, Hungerford, Berkshire RG17 0EY) (the "Assignor");
- (2) Theodoulos Papanicola, Administrator of the Assignor, of Bond Partners LLP, The Grange, 100 High Street, London N14 6TG, UK (the "Administrator"); and
- (3) Fenzian Limited, a British Company, whose registered office is at Winter Hill House, Marlow Reach, Station approach, Marlow, Buckinghamshire SL7 1NT, UK (the "Assignee").

### **Whereas:**

- (A) The Assignor is recorded as the legal and beneficial owner of the patent applications and registrations listed in the attached Schedule (the "Patents")
- (B) The Administrator was appointed Administrator of the Assignor on 2 September 2010 in the High Court of Justice, Chancery Division, Birmingham District Registry (No. 8403 of 2010) under paragraph 22 of Schedule B1 to the Act.
- (C) The Assignor by agreement dated 2 September 2010 (the "Agreement") assigned all of its right and interest in and to the Patents and all its rights attaching thereto to the Assignee.

It is hereby confirmed as follows:

### **1 Assignment**

- 1.1 In consideration of £1 (one pound sterling) and the amount set down in said Agreement (the receipt of which is hereby acknowledged by the Assignor), the Assignor acting by its Administrator hereby confirms the assignment, and to the extent not already assigned assigns, to the Assignee absolutely and with no title guarantee the Patents and all the rights powers and liberties and Immunities conferred on the proprietor by the grant thereof including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of any published specification of the Patent or accompanying any application therefor prior to the date hereof TO HOLD the same unto the Assignee absolutely.
- 1.2 The Assignor and the Administrator hereby agree that the Assignor and/or Administrator (but only so long as he retains office in relation to the Assignor and provided that all and any personal liability of the Administrator is expressly excluded) shall at the Assignor's expense and on a full indemnity will at the

request of the Assignee cause the Assignor to execute and sign all such documents (in such form that the Assignor's solicitors shall approve) as and do such acts as may be reasonably necessary to give full effect to this Assignment and to record the Assignee as proprietor of the Patents.

## **2 Law and Jurisdiction**


- 2.1** This Confirmatory Assignment shall be governed by and construed in accordance with English law.
- 2.2** All parties irrevocably agree that the Courts of England are to have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this Agreement. All parties irrevocably submit to the jurisdiction of such courts and waive any objection to proceedings in any such court on the ground of venue or on the ground that the proceedings have been brought in an inconvenient forum

## **3 Administrator's Liability**


The Assignee acknowledges and agrees that in the negotiation and completion of this agreement the Administrator is acting only as agent of the Assignor and that notwithstanding that this agreement shall have been signed by the Administrator on behalf of the Assignor it is expressly agreed and declared that no personal liability under or in connection with this agreement shall fall on the Administrator or his firm, partners or employees whether such liability would arise under the Insolvency Act 1986 or otherwise and the Administrator is party to this agreement in his personal capacity only for the purpose of receiving the benefit of this sub-clause and the exclusions, limitations, undertakings, covenants and indemnities in his favour in this agreement.


