PATENT ASSIGNMENT OF SECURITY



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Issuer does hereby assign unto Collateral Agent for its benefit and for the ratable benefit of Purchasers and grant to Collateral Agent for its benefit and for the ratable benefit of Purchasers a security interest in and to the Patents, and recordings and applications therefor, which assignment and security interest shall secure all the Obligations (as defined in the Note Purchase Agreement) in accordance with the terms and provisions of the Agreements.

Issuer expressly acknowledges and affirms that the rights and remedies of Collateral Agent and Purchasers with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.



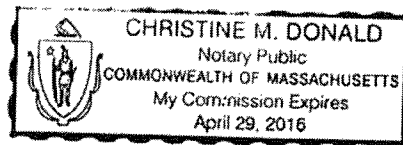
