RE-ASSIGNMENT OF CERTAIN PATENTS AND PATENT APPLICATIONS

This Re-Assignment of Certain Patents and Patent Applications ("Re-Assignment") is made this 18 day of February, 2011 by Wells Fargo Bank, National Association, successor by merger to Wachovia Bank, National Association (hereinafter referred to as "Agent") to AEP Industries, Inc. ("Borrower").

WHEREAS, Agent has agreed, at the request of Borrower, to reassign to Borrower the Film Cutter patents and patent applications listed in the Security Agreement that were conditionally assigned to Agent and retain the security interest therein evidenced by the Security Agreement (the "Security Interest");

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the undersigned agree as follows:

1. Agent does hereby re-assign to Borrower the patents and patent applications set forth in Schedule "A" attached hereto (collectively, the "Patents"), including the right to sue for past infringement and to collect any damages resulting therefrom.

2. This Re-Assignment does not limit, impair or otherwise affect in any manner the Security Interest of Agent, for itself and the benefit of Lenders, in all right, title and interest of Borrower in and to the Patents.
