ASSIGNMENT

WHEREAS, we, Andreas F. United States Patent Application Number 10/915,687 is a continuation-in-part of United States Patent Application 10/201,543, entitled "Self-Contained Portable Inspection System and Method", filed on July 23, 2002 and now United States Patent Number 6,843,599;

AND WHEREAS, Rapiscan Security Products, Inc. (hereinafter "ASSIGNEE"), a corporation, with its principal place of business at 2805 Columbia Street, Torrance, CA 90503, desires to acquire the entire right, title, and interest in and to the said improvements and the said Application:

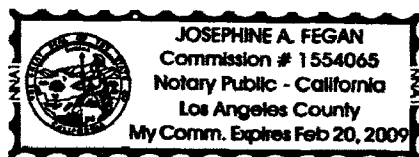
