successors, assigns, nominees, or other legal representatives all facts known to Assignor respecting said invention, whenever requested, and testify in any legal proceedings, sign all lawful papers, execute and deliver all divisional, continuing, and reissue applications, make all rightful oaths or declarations, and do all lawful acts requisite for the application for such divisional, continuing, or reissue applications, or the procuring thereof, and that if and when Assignee, its successors, assigns, nominees, or other legal representatives desire to file a disclaimer relating thereto, Assignor will, upon request, sign and deliver all lawful papers requisite for the filing of such disclaimer.

Assignor further covenants and agrees that Assignor will, at any time upon request, do everything possible to aid Assignee, its successors, assigns, nominees, or other legal representatives, to apply for, obtain, and enforce proper patent protection for said inventions in all countries, according to the International Convention and the Patent Cooperation Treaty, and all the laws and treaties in force, all without further consideration but at the expense of Assignee, its successors, assigns, nominees, or other legal representatives.

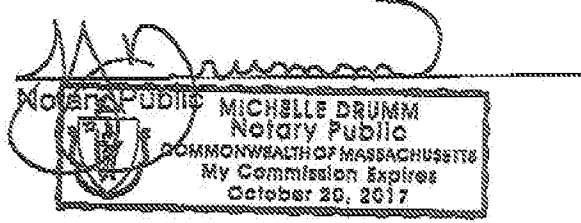
