Ahold Coffee Company B.V. , hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interests granted herein and that **Ahold Coffee Company B.V.** , will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and **Ahold Coffee Company B.V.** , binds itself and its heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to the said **Meccano Asia Ltd.**, its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said **Meccano Asia Ltd.**, its successors and assigns to file applications for the said improvements and invention in any country where it may elect to file such applications, and that may be necessary to vest in the said **Meccano Asia Ltd.**, its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.

AND, **Ahold Coffee Company B.V.** , further covenants and agrees, in consideration of the premises, that it, its executors and administrators will, at any time upon request, communicate to the said **Meccano Asia Ltd.**, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to it or its successors and assigns, and that it will testify as to the same in any interference or other proceeding when requested to do so by the said **Meccano Asia Ltd.**, its successors and assigns.

The undersigned hereby grants the law firm of Birch, Stewart, Kolasch & Birch, LLP the power to insert on this Assignment any further identification that may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
