Convention or Union; and all rights of priority resulting from the filing of the Patent Application, the same to be held and enjoyed by BBC International LLC, its successors and assigns, for their own use and enjoyment, to the end of the term or terms of such patent as may be granted on the Patent Application or on any other application claiming any right of priority to the Patent Application, as fully and entirely as the same would have been held and enjoyed by Gilberto Debiase if this assignment and sale had not been made; together with and including without limitation any and all claims for damages by reason of past infringement of any such patent, with the right to sue for and collect the same for the sole and exclusive use and enjoyment of BBC International LLC, its successors and assigns.


