

The undersigned, Craig T. Boyd, Vice President of IDEX AODD, INC., does hereby certify:

1. The name of the corporation is IDEX AODD, INC., a Delaware corporation (the "Corporation").
2. The Certificate of Incorporation of the Corporation was filed by the Department of State of the State of Delaware on August 20, 1986.
3. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation from IDEX AODD, INC. to WARRAN RUPP, INC.
