Assignment**

NOW THEREFORE for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all of Assignor's worldwide right, title, and interest in and to the Patent Rights, (including the right to seek damages and other equitable relief based upon activities that took place prior to the Effective Date), to be held and enjoyed by Assignee, for its own use and benefit, and by Assignee's successors and assigns for their own use and benefit, for the full duration of the terms for which Patent Rights may be granted in any country, subject to the terms and conditions of the Agreement.


