ASSIGNMENT AGREEMENT

This Assignment Agreement ("Assignment") is entered into by and Richard W. ASSIGNMENT:

1. Assignor hereby assigns to Assignee its entire worldwide right, title and interest in and to Assignor's Patents, including the entire worldwide right, title and interest in and to any reexamination or reissue of the Patents. This includes, without limitation, the right to prosecute, and receive, all damages, royalties, awards and compensation for past, present and/or future infringement.
2. Assignor agrees to do the following without further consideration, in order to carry out the intent of this Assignment:
 - i. Execute all oaths, assignments, applications, and other papers necessary or desirable to fully secure to Assignee the rights, titles and interests herein conveyed; and
 - ii. Generally do all lawful acts for vesting in Assignee the rights, titles, and interests herein conveyed.
3. Assignor has not made and will not hereafter make any assignment, grant, mortgage, license, or other agreement affecting the rights, titles, and interests herein conveyed to Assignee.
4. Assignor hereby represents and warrants that Assignor is the owner of all rights, title, and interest in the Patents and that Assignor has the authority to assign the applicable Patents pursuant to this Assignment.
