ASSIGNMENT

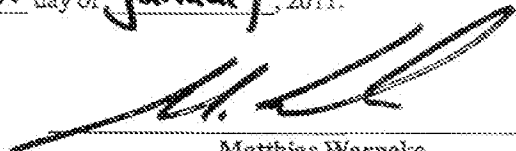
