## PATENT LICENSE AGREEMENT

THIS PATENT LICENSE AGREEMENT (the AGREEMENT) is made as of the 3rd day of March 2011 between Artco-Bell a corporation organized and existing under the laws of the State of Texas, having a place of business at 1302 Industrial Blvd., Temple, TX 76504 (LICENSEE), and by Schoolhouse Furniture, Inc., a corporation organized and existing under the laws of the State of Delaware, having a place of business at 415 W. 22nd St. Ste. 700. Oak Brook, IL 60523 (LICENSOR), the parties agree as follows:

WHEREAS LICENSOR is the owner of United States Patent No. D625,532 entitled "DESK" (the PATENT); and

WHEREAS LICENSOR and LICENSEE as related corporate entities with common and mutually aligned interests have agreed to enter into this AGREEMENT, wherein LICENSOR grants to LICENSEE a perpetual and nonexclusive, worldwide, royalty-free license to utilize the PATENT,

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the agreements herein contained (the receipt and sufficiency of which consideration are hereby acknowledged by the parties), the parties covenant and agree with each other as follows:

GRANT: LICENSOR hereby grants to LICENSEE a perpetual and nonexclusive, worldwide, royalty-free license to make, use, sell, and/or offer for sale the product embodied in the PATENT, with the right to sublicense.

COOPERATION: Each party will execute any instruments reasonably believed by the other party to be necessary to implement the provisions of this Agreement.





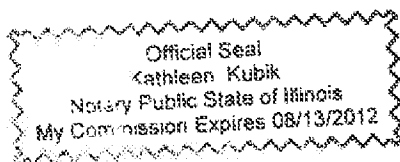
