ASSIGNMENT AGREEMENT

THIS AGREEMENT is between

(i) Pedestal Designs Incorporated, a corporation organized and existing under the laws of the State of California, U.S.A., of 931 Hamilton Avenue, Menlo Park, CA 94025, USA. (hereinafter PEDESTAL DESIGNS), and

(ii) Petra Reed, a citizen of the United States, of 229 Fulton St., Redwood City, CA 94062, USA, (hereinafter PETRA REED), and James P Reed, a citizen of the United States, of 229 Fulton St., Redwood City, CA 94062, USA (hereinafter JAMES P. REED), PETRA REED and JAMES P. REED being hereinafter collectively referred to as INVENTORS.

WHEREAS

A. INVENTORS have made an invention or inventions relating to PEDESTALS, hereinafter referred to as INVENTION, as described in (1) United States Patent No. 7,407,144, issued to INVENTORS on August 5, 2008, (2) United States Patent No. 7,722,005, issued to INVENTORS on May 25, 2010, and (3) United States Patent Application No. 11/732,215, filed by INVENTORS on April 2, 2007, and entitled Block Pedestal, said Patents and Patent Application being hereinafter collectively referred to as PATENT RIGHTS.

B. Each of INVENTORS, at the time INVENTION was made, was under an obligation to assign all of his or her rights in INVENTION to PEDESTAL DESIGNS, and

C. PEDESTAL DESIGNS wishes to acquire the entire right, title and interest in INVENTION, including but not limited to, PATENT RIGHTS and any other proprietary rights for INVENTION throughout the world, and each of INVENTORS wishes to assign to PEDESTAL DESIGNS his or her entire right, title and interest in INVENTION.

PEDESTAL DESIGNS and INVENTORS have agreed as follows.

1. Each of INVENTORS, in consideration of the sum of \$1.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby assign to PEDESTAL DESIGNS, its successors and assigns, and PEDESTAL DESIGNS accepts, his or her entire right, title and interest in INVENTION, including but not limited to PATENT RIGHTS and any patent, reissue or continuation derived from PATENT RIGHTS.

2. Each of INVENTORS covenants that he or she has the full right to convey the right, title and interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith.

3. Each of INVENTORS covenants that he or she will communicate to PEDESTAL DESIGNS any facts known to him or her concerning INVENTION, and will, at the expense of PEDESTAL DESIGNS, testify in any legal proceedings concerning INVENTION, sign any lawful paper, and generally do everything possible to assist PEDESTAL DESIGNS in obtaining and enforcing Letters Patent, Utility Models, and other Proprietary Rights for INVENTION throughout the world.
