Assignor authorizes and requests the Commissioner of Patents and Trademarks and the corresponding entities or agencies in any other applicable countries to record Assignee as owner of the Patents, including any continuations, divisions, continuations-in-part, reissues, reexaminations or extensions thereof, and to issue any and all letters patent thereon to Assignee, as assignee of the entire right, title and interest in, to and under the same. Notwithstanding the foregoing grant of such authority, nothing herein shall alter, amend or otherwise revise the terms and conditions of the Cross License.

Assignor and its affiliates shall provide Assignee, Assignee's successors, assigns or other legal representatives, such cooperation and assistance as Assignee may reasonably deem necessary or desirable, at Assignee's sole cost and expense, (including the execution and delivery of any and all affidavits, declarations, oaths, assignments, powers of attorney, and exhibits to any of the foregoing, or other documentation as may be reasonably required) to (i)
