THIS INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT AGREEMENT is made on 20 October 2010 between:

(1) **CTS Technologies AG**, a company incorporated in Switzerland, registration number CH-170,3.027.867-1, whose registered office is at c/o Kerdos Asset Management AG, Oberneuhofstrasse 5, 6340 Baar, Switzerland (the "Assignor"); and

### THE PARTIES AGREE as follows:

## 1. Definitions

# 2. Assignment

- 2.1. The Assignor hereby assigns and transfers to the Assignee:
- a) all of the Assignor's rights to the Patents, including but not limited to:

- The Assignor is the sole owner and the sole registered holder of the Intellectual a) Property Rights and the Assignor has the full legal right to assign the Intellectual Property Rights to the Assignee;
- No licences, options, pledges or other rights of similar nature have been granted b) to any third party in respect of the Intellectual Property Rights and the Assignor assigns the Intellectual Property Rights to the Assignee without any restrictions, reservations or limitations whatsoever;
- The registrations, or where relevant the applications, for the Intellectual Property **c**) Rights are valid, subsisting and have not been withdrawn, lapsed, cancelled or abandoned otherwise as detailed in the schedules hereto. All applicable fees have been paid and all other actions or measures required to maintain the Intellectual Property Rights have been duly and timely taken;
- To the best of the Assignor's knowledge, there are no circumstances to the effect d) that the Intellectual Property Rights will be declared wholly or partially invalid or restricted, without the holder's consent, prior to the end of the Intellectual Property Rights' maximum term of protection; and
- There are no litigation or revocation proceedings pending or threatening that may e) materially affect the value of the Intellectual Property Rights.
