DEED OF ASSIGNMENT

THIS ASSIGNMENT is made effective on 18 March 2004

between

NOW THIS DEED WITNESSETH as follows:-



 - a. all right, title, benefit and interest in and to the Application including any ensuing national patent applications, and any and all patents that may issue from said patent applications, including any and all reissues, extensions, substitutions, confirmations, registrations, revalidations, renewals, additions, continuations, continuations-in-part, or divisionals of or to the Application,
 - b. the right to sue and claim in respect of any past infringements thereof **TO HOLD** unto the Assignee absolutely,
- 2. Each party agrees with the other that it will sign, execute and do at the request and expense of the other, if and when reasonably required to do so by the other, all documents acts and things as may be necessary or desirable to enable the other to enjoy the full benefits of the rights assigned herein.

3. This Assignment will be governed by and construed in accordance with the Laws of England and will be subject to the jurisdiction of the Courts of England.






