This Assignment is governed by the substantive laws of the state of New York.

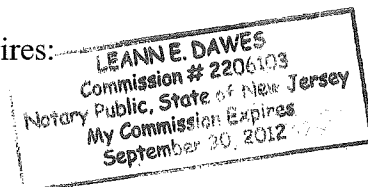

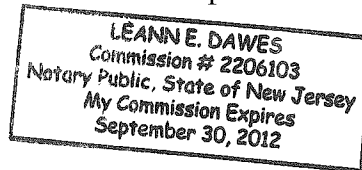

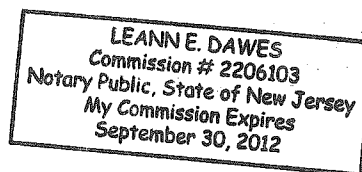
