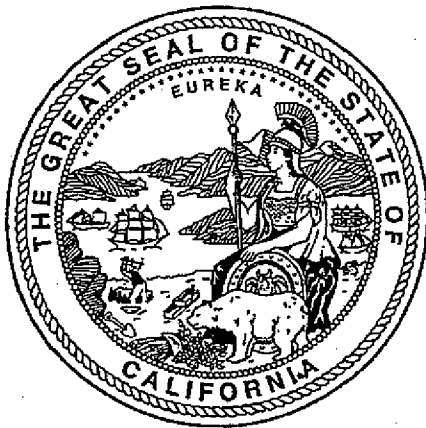

**THIRD AMENDED AND RESTATED  
ARTICLES OF INCORPORATION**

OF

**TRUSI TECHNOLOGIES, INC.**

Sergey Savastiouk and Anna Savastiouk hereby certify that:

1. They are the duly elected and acting Chief Executive Officer and Secretary, respectively, of TruSi Technologies, Inc., a California corporation (the "Corporation").
2. The Articles of Incorporation, as amended and restated, of the Corporation are hereby further amended and restated to read as follows:

**ARTICLE I**

The name of the Corporation is ALLVIA, Inc.

**ARTICLE II**

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

**ARTICLE III**

A. The Corporation is authorized to issue two classes of shares to be designated respectively Common Stock ("Common Stock") and Preferred Stock ("Preferred Stock"). The total number of shares of all classes of capital stock that the Corporation is authorized to issue is Three Hundred Eleven Million (311,000,000) shares. The total number of shares of Common Stock the Corporation shall have authority to issue is One Hundred Sixty-Nine Million (169,000,000). The total number of shares of Preferred Stock the Corporation shall have authority to issue is One Hundred Forty-Two Million (142,000,000).

B. Twelve Million (12,000,000) shares of the Preferred Stock are designated "Series A Preferred Stock." Fifty Million (50,000,000) shares of the Preferred Stock are designated "Series B Preferred Stock." Eighty Million (80,000,000) shares of the Preferred Stock are designated "Series C Preferred Stock." As used herein, "Preferred Stock" shall mean, collectively, the Series A Preferred Stock, the Series B Preferred Stock, and the Series C Preferred Stock. The powers, preferences, rights, restrictions, and other matters relating to the Preferred Stock are as follows:
